QCCIFD Meeting Minutes – July 15, 2015

The Queen Creek County Island Fire District (QCCIFD) administrator and governing board met in a properly posted open public meeting on Wednesday, July 15, 2015. The meeting was held at the Town of Queen Creek – Town Hall Meeting Room MSB – Palo Verde, located at 22358 S. Ellsworth Road, Queen Creek, Arizona.

The following agenda items were considered at the meeting:

- A. The meeting of the QCCIFD board was called to order at 6:32 p.m. by board member Memmott.
- B. Roll Call: Board members Memmott, Ruscetti and Woodruff (attending telephonically) in attendance.

Item 1: Consideration of appointing an interim member to vacant positions on the governing board pursuant to A.R.S. §48-852(B) (QCCIFD #15-018):

QCCIFD resident Daniel Kuefner, in attendance at the meeting, expressed interest in serving on the governing board. Mr. Kuefner answered general questions from the board.

Motion by Memmott / 2nd by Ruscetti: To appoint Daniel Kuefner to a vacant board seat; Passed 3-0.

Item 2: Consideration of electing a chairperson and clerk from the Queen Creek County Island Fire District governing board member pursuant to ARS §48-852(D) (QCCIFD #15-019)

Consultant John Flynn explained the statutory requirements requiring the board to elect a chair and clerk from its members.

Motion by Ruscetti / 2^{nd} by Kuefner: To nominate Memmott as board chair; Passed 4-0.

Motion by Memmott /2nd by Kuefner: To nominate Ruscetti as board clerk; Passed 4-0.

Due to a conflict, member Woodruff vacated the meeting.

Motion by Memmott / 2nd by Ruscetti: To approve the May 20, 2015 minutes as presented; Passed 3-0. (Absent – Woodruff)

Motion by Ruscetti / 2nd by Memmott: To accept the finance reports as presented; Passed 3-0. (Absent – Woodruff)

b) Review of invoices / payables and authorization for payment (QCCIFD #15-022):

Consultant Vaughn presented invoices (included within board packet) and warrants (checks) for board review and authorization for payment: PolicyLogic, LLC (\$1,974.48); Angela Bertram, CPA (\$292.50); Clerk of the Board (\$456.32).

Motion by Memmott / 2nd by Kuefner: To authorize payment of the invoices presented; Passed 3-0. (Absent – Woodruff)

Item 7: Public Hearing in accordance with A.R.S. §48-853.A.2: To hear taxpayer's comments on the proposed fiscal year 2015/2016 Queen Creek County Island Fire District revenue and expenditure budget (QCCIFD #15-n/a)

Chair Memmott opened the public hearing for comment. No public present at the meeting. Chair Memmott closed the public hearing.

A detailed description of the cost increases due to capital projects and PSPRS unfunded liability were discussed. Consultant Flynn answered general questions from the board regarding the budget. Gloria Moore, Sr. Financial Services Analyst for the Town of Queen Creek, was also in attendance and answered general questions from the board.
