Consultant Flynn reviewed the budget documents provided within the board packet: FY 13/14 tentative budget and Town of Queen Creek fire district cost formula (IGA Exhibit A). Flynn detailed the methodology used to calculate fire service contract cost estimates.

Flynn reviewed revenues and expenditures with the board, along with estimates for year end balances. Flynn advised the budget may be adjusted to address end of year general fund cash balance.
